Mike Bottini, Wildlife Biologist- Seatuck Environmental Association

- Updates: natural recolonization of LI;
- Concern for road crossings, need ladders/culverts,
- Specific site off of Rte 58; Tupelo wetland; Developer convinced DEC not to classify as wetland so it was developed -> no more greenbelt corridor for wildlife.
- Bottini notes that DEC Trapping regulations for other mammals are allowed although we do not know their populations → He will be starting to study these mammals.
- Kevin Macdonald suggests: consider bond act for the State, \$4 Bil, Bottini should apply with an otter project
- Mark Haubner: wants to be roped into otter talks

4:15 PM Broad Cove Land Acquisition

Julie Wesnofske, Project Manager- Peconic Land Trust

- Broad Cove: Former duck far, 100 acres, high priority for decades.

- Marketing for a resort, special permit application to town of riverhead end of 2020, landowners accepted a bid and contracts were out but entertained an offer from the land trust-> \$11.5 mil; secured 6 clines of credit, doners will be paid back when they transfer property to the DEC
- High profile: Kevin suggests partnership between Pec Land Trust & PEP in restoration of the site

Julia Priolo, Senior Environmental Analyst- Suffolk County Dept. of Health Services

- SIP: SC Septic Improvement Program: 10k + more + design services
- NYS SSRP; NYS Septic System Replacement Program// They do not do anything to remove N from wastewater
- IA's quickly replacing failing cesspools especially during pandemic
- Mike/Patrice concern on if it is more cost affective and faster to sewer than individual septic tank upgrades
